## 3. Briefings

a. Options for Rosemont – Don Lockhart, Executive Officer, Sacramento Local Agency Formation Commission (LAFCo)

Formed in 1950's. The Commission has seven members: Two members of Board of Supervisors, (Frost, Peters, and Serna as alternate), Sacramento and another city council person, two from Special Districts, and one public member.

Becoming a new city or CSD, or being annexed by an existing city or CSD can be initiated by citizens groups, city councils, and such and they have to pay for process.

Fiscal Consultants must then be hired and the County must be kept financially whole for a period of years, likely about 25. Rosemont is in the Sacramento sphere of influence but Rancho Cordova could add us to theirs preliminary to annexation.

Arden Arcade spent close to \$500K in its cityhood attempt. Forming a CSD with limited powers would be \$50-\$100K

LAFCo would be curious about any proposed boundaries. They should be chosen carefully to avoid inclusion of probable enclaves of opposition or any islands. Annexation can be stopped by 50% of property owners and voters
