4. Special workshop on Major development around Rosemont

Mike Isle from Teichert development

Supervisor Don Nottoli remarked it could be 30-50 year build-out. Rings of development can have varied densities. Calvine Road at Highway 99 is an example of a well-developed commercial area. Supervisor Nottoli suggested some possible ways that funding for Rosemont might be secured to make needed community improvements as other developments near; RCA will work with him on identifying those possibilities. County can learn from City experience, especially Elk Grove's.

Planner Todd Smith said planning maps are general to land use and don't address details of usage implementation.

Director Sloan said it is hard to place new development within existing structures Smith said each project is by separate application. Newbridge is well along in process. CPAC has role. Response to public comment can be extensive or brief depending on level of comment. West Jackson is about a year behind some others.
