SSD - Deputy Francis

Homeless – warming centers closed in the city. One in Rancho Cordova is bringing more homeless into our area, along with river access and Light Rail; Jackson/Mayhew area still being addressed – school and golf course assisting

Crime – Uptick in shootings; with one exception (daughter/mother shooting), shootings involve subjects not residents of Rosemont; shooting on Henley Way has brought a "memorial" to the corner of Andedon & Henley. Officer Francis suggests that the County can do a clean-up.

SSD working with businesses on Kiefer to form Business Watch.

SSD and their media will be attending the Santa Parade on Monday night.
