7:31pm – Jasmine Asnine & Rebecca Sloan representing Don Nottoli's office. Rebecca Sloan gave a presentation about the homeless situation in our community 8900 block of Folsom Blvd & 9500 block of Folsom Blvd. The county is looking for places to house the homeless. In some cases, social workers come out during a crisis to triage the homeless person. The county is expanding the community service team building structure team to same location. At the 8900 block Folsom Blvd CST (Community Service Team) will be going out next week. When cleaning up encampments, the county can't toss homeless camps property. Forensic clean up-dangerous items, soiled health risk will be removed. Issue with private vs public property, trespassing citations. Drainage for the water ways being blocked. County will have an online meeting Saturday at 1pm county website redistricting, 3 draft maps. Public proposed, public comment, short process Nov. 17th must take action to adopt new districts. A discussion about Rancho Cordova and Rosemont may not be in the same districts.
