3. **Status Reports** (in addition to those in the Board Packet)

- a. Law Enforcement- follow up on recent homicide on Kiefer. No updates. Homeless are tapping into the power source at Rosemont Community Park. Residents reported a person knocking on doors during overnight hours and looking under mats. Als reports of prowlers, attempted theft of car, stolen vehicle recovered but with serious damages. Homeless are back at the shuttered Del TAcO.
 - i. Neighborhood Watch: registration of new groups are completed online on the Rancho Cordova Police Department website (also serving the Sacramento Sheriff East Command Division).
 - ii. CHP: a fatal accident near Jackson and Hedge. Public Service Announcement - distracted driving cost 3,142 lives in 2019. This includes talking, using stereos, cell phones; eating and drinking. New law - 2nd cell phone violation while driving is now a moving violation. CHP teaches monthly "Start Safe" driving courses to teenagers.
- b. County report by Jasmine Osmany- The 5th Supervisorial District has grown substantially and per law, all districts must have similar populations, allowing for a small variance. There are mapping tools online to allow residents to design districts. Districts should avoid breaking up recognized neighborhoods. Board of Supervisors adopt new District boundaries by 12/15/21. RT clean up 80 yards of debris at Bradshaw and Butterfield light rail station. In the 95826 zip code 358 new cases of COVID ini the past 30 days. 7 or 8 new cases were residents not vaccinated. Elder Creek homeless camp has removal orders.
